

**Continuing Education Certificates must be sent to the Electrical Division before renewing on-line.**

The holder of an expired license may renew the license until March 31, 2013 upon payment of the license fee plus 10% of the renewal fee for each month or portion there of past the expiration date. After March 31, 2013 a license holder will be required to pass an examination before the license is issued.
